How We Use Personal Data

Who We Share Personal Data With

Employees

How Long We Store Personal Data

User data will be stored until the purpose the data was collected for has been achieved.

You will be notified if your data is kept for longer than this period.

How We Protect Your Personal Data

We take the security of your personal information seriously. All data submitted through our website forms or lead magnets is transmitted using secure, encrypted connections (HTTPS). The information is stored in password-protected systems provided by trusted third-party platforms (such as Wix and Google), and access is restricted solely to the business owner.

As a sole trader, I (Alex McPherson) am the only person with access to this information. I do not share, sell, or disclose personal data to any third party unless explicitly required to deliver services you have requested or by law. All reasonable steps are taken to protect your data from unauthorised access, misuse, or loss.
